## October presenter: Kathleen Duncan

I have long admired the pierced work by such artists as Binh Pho, Joey Richardson, and Gordon Pembridge. When I retired in 2014, I took the plunge and bought a micro motor and an air-driven dental drill. Since then, I've learned a lot and had a lot of fun piercing thin-turned pieces.

This demo begins with a discussion of thin turning. To pierce, the wood must be turned to a thickness of about 2 mm. Grain orientation is very important when

you intend to pierce a turning. I'll go through the steps I take when turning thin. I'll also discuss the tools I use as well as "dry" vs. "green".

Once a piece is turned, the next step is to lay

out the design. In this portion of the demo, I'll discuss sources of design inspiration, curves, proportion, and laying out the design. The layout is important – it is worth taking the time to make sure you are satisfied with the design. I'll show several different styles of pierced-hole size, shape, and placement. This part of the demo includes a very brief refresher course on geometry.

I'll demonstrate piercing using a high-speed dental drill. I'll show various methods of de-fuzzing, removing the "burn", sanding, and finishing the piece. For this portion, I'll use a micro motor carving tool as well as a few hand devices.



### Bylaws Revisions for vote by Membership Jeff Zens, Past President

For over eight years, Henrik Aberg served the club in multiple roles - newsletter publisher, Treasurer, coordinator of all things membership, and a bunch of other jobs too numerous to mention. Last January, he decided to hang up the spurs and move on to greener pastures...or some other idiom of your choosing. Since then the club's Board of Directors has been discussing the best way forward to get Henrik's former workload distributed. This article lays out that path.

The Board has decided to formalize the membership-related tasks in a new post called Membership Director, separating these from traditional Treasurer duties. This post will be an appointment by the club President and a member of the Board of Directors, but not an officer. This arrangement was agreed upon to avoid the two-year term limit imposed on officers, and does not require the Membership Director to be approved by vote. In order to keep the number of Board members at seven, the Membership Director replaces one of the two members-at-large who presently serve. The Membership Director will handle all membership-related tasks, among

which are the club roster and photo directory. All of the forms, spreadsheets, and other record-keeping methods are mature and well developed, so no new recordkeeping methods will be necessary - just maintaining what is already in place.

To move forward, a few bylaw modifications are necessary. The revised language is found below. To better understand the changes, new language is generally **bold and underlined**. Current language to be replaced or removed is shown redlined with strikeout. The Board encourages you to read through the proposed revisions, and ask questions of any Board member. These proposed changes will be the subject of a vote of the club members present at the October meeting.

#### ARTICLE IX - EXECUTIVE BOARD

The WVW Executive Board shall consist of the President, Vice President, Secretary, Treasurer, Past President, Membership Director and two (2) one (1) members elected by the membership. In the event that a member is elected to serve two positions, an additional board member shall be is elected to preserve the number of board members at seven (7). The WVW Executive Board shall be charged with day-to-day conduct of the affairs of the WVW club, and with making decisions on such matters which do not require a vote by the general membership. The President shall be Chairperson of the Executive Board. This Executive Board shall meet at least quarterly. The Executive Board shall be responsible for all assets acquired by the WVW.

#### **ARTICLE VIII - OFFICERS**

- 1. Titles: The officers of the WVW shall be President, Vice President, Secretary, and Treasurer.
- 2. President: The President shall be the principal executive officer of the WVW. The President's duties include: Supervise and control all of the business and affairs of the WVW, conduct WVW meetings, and appoint and work with the various standing, subcommittees and Ad Hoc committees of the WVW. The President shall also appoint a Membership Director, whose duties are described in Article VIII(A), below.
- 3. Vice President: In the absence of the President, either due to inability or refusal to act, the Vice President shall perform the duties of President, and when so acting, shall have all the powers of and be subject to all the restrictions upon the President. The Vice President shall be responsible for public relations, scheduling and overseeing the monthly program.
- 4. Secretary: The Secretary shall take and keep in proper order the minutes of the WVW meetings, and see that all notices are duly given in accordance with the provisions of these Bylaws or as required. The Secretary will also act as the WVW Historian. In general, the Secretary shall perform all duties incident to the office of Secretary.
- 5. Treasurer: Duties. The Treasurer shall:
- collect all membership dues; and ensure that a current membership roster is maintained and published;
- maintain current and accurate records of all receipts, disbursements and accounts of any sort that flow through or belong to the WVW;
- develop and promulgate cash handling procedures that ensure accurate accounting of all club cash transactions;
- maintain an accurate and detailed inventory of the physical assets of the club, and prepare an annual inventory report for the Board of Directors' first quarter meeting each year. The Treasurer shall obtain the assistance of other club members, as needed, to complete this inventory. The annual inventory report shall contain, at a minimum, detailed information about the type of asset, its approximate value or purchase price, if known, and its current location
- prepare a budget proposal for the Board of Directors first quarter meeting each year that provides, at a minimum, the following information:
- The previous year's adopted budget and actual experience, in a form developed by the Treasurer and approved by the Board;
  - A proposal for the current year's operating budget for consideration and adoption by the Board;
- Detail sufficient to track all income and expenditures by category (membership dues, equipment purchases, demonstrator fees, demonstrator expenses, etc.)

The Treasurer shall keep current the Business Registration with the Oregon Secretary of State, and shall renew these filings as required by said office. The Treasurer shall be the Authorized Representative for the WVW Club as defined by said office.

- 6. Term of Office: Each officer shall hold office for one year from January 1 to December 31. No person may hold the same office for more than two consecutive full terms, except for the Treasurer, who may hold office for unlimited consecutive full terms.
- 7. Vacancies: A vacancy in any office shall be filled by Presidential appointment with subsequent Executive Board confirmation. An individual filling the unexpired portion of a term will not be barred from being elected to an additional two consecutive terms.

8. Removal: Any officer elected or appointed may be removed when it is deemed that the best interests of the WVW would be served by such removal. This will be accomplished by a majority vote of the WVW's members who are present at the time of the vote, so long as at least 50% of the paid up participating members are present, and a recall or removal intent has been published in advance in the monthly newsletter.

## **Article VIII(A) Appointed Positions**

1. Membership Director: Duties The Membership Director is generally responsible for all Club matters that relate to developing and retaining members of the Club, and all activities involved with accurate membership record-keeping. To the extent that membership duties might involve financial transactions, the Membership Director and the Club Treasurer will work closely to ensure that the duties of each position are accomplished. The duties of the Membership director are generally defined in Appendix A of these bylaws, and this Appendix may be periodically modified by the Board in its administrative role.

**September Sawdust Session:** As noted above, the September version of our sawdust session went into the afternoon and kudos to those that took part! I bugged out at noon as a bike ride was calling my name... I'd love to see a pic or two and hear how it went. Well enough that it is on the schedule for next week for sure!

The session started with a bit of drooling as we gathered around Darcy's new monster Rikon. It's a beautiful machine and I look forward to giving it a spin!































## **September meeting notes:**

**Pres. Marc** gavelled the meeting to order a couple minutes late as we had a large number of visitors due to the State Fair and friendly welcomes were being offered! 57 people were at the meeting.

-visitors and new members spoke a bit about why they were interested in the club and offered fun tidbits including owning a lathe without knowing anything about it and being encouraged to try something new by their grandkids.



- -reviewed the Craft Supplies order status
- -announced the experiment to include afternoons in the Sawdust Sessions
- -announced that most of the long overdue books made it back into the library
- -reviewed the Empty Bowls event and status and asked for a pricing group

Member Chuck led the Show-n-Tell and all pieces were discussed (See Gallery below) (Thanks Chuck!)

Randy covered possible wood gathering and let folks know he had some black walnut up for grabs (George and I picked up some and it's beautiful.)



### **Presenter: Savannah Stanton**

Savannah is currently teaching in the woodshop at Amity HS and shared that she studied wood and turning with Seri Robinson (AKA Dr. Spalting) at OSU!

The following are some of the notes I took on her presentation. She is a left handed turner, which was fascinating, but the pics I grabbed were nowhere near as valuable as what you saw via the video system due to her positioning at the lathe. My apologies.

-Savannah began with a talk about grain including the rays and how figured wood is always challenging grain.

-She passed around pieces in progress (amazing spalting!) and noted she gets much of her wood from North Woods Figured Woods (located in Gaston https://www.nwfiguredwoods.com/)

-She mounted a blank (about 6"x6"x2") between centers to start

-Savannah used a 3/8" bowl gouge with a more or less traditional grind which she

sharpens freehand so couldn't state a definitive angle

-She recommends using a faceplate for stability in most cases -Savannah started at about 500 rpm and carefully cleaned the base paying close attention to getting clean cuts on the corners as they would be staying

hill cuts on the wings

-She cautioned us to look to the top of the spinning piece to see the profile develop as looking at the cutting edge is misleading

-Savannah advised finding the edge carefully and lifting the handle to find a comfortable cutting position

-She recommends choking way up and bracing the handle

against the body with your forearm and doing final cuts with the whole body


-Once the wings were done, Savannah moved to hollowing the bowl which she will do from the inside out often, but finishing with long smooth final cuts going downhill into the bowl

-Savannah said taking off the tenon is up to us, but that she often uses a sanding disc on a drill press

as her tenons are short and the sander takes very little time.

-Savannah ended on a cautionary note about safety (she knows a turning tragedy) and reviewed the importance of the facemask, no loose clothing, and never turning without someone knowing










## **Empty Bowls 2023**

For the 3rd time Willamette Valley Woodturners is partnering with the Willamette Art Center and their ceramic artists for the annual Empty Bowl event.



Empty Bowls is an organization designed to help end hunger. Empty Bowl events are held hundreds of times a year all over the country. Each event is designed around the needs of the local community. Our event helps raise money for the local **food bank**.

The event itself is a sale of collected bowls and art pieces at an invitation only event on a Friday evening and to the general public on **Saturday November 18**.

Willamette Valley Woodturners has a goal of at least 100 bowls this year. It is a small number compared to the ceramic artists but our bowls are very appreciated. They add a level of interest and variety to the sale.

The most frequently asked question is "what kind of bowl should I make?"

You should make and donate bowls that you are proud of. Size can vary. Wood species can vary. The bowls can be simple or embellished. They can be functional or decorative.

The one constant should be quality. Donate something that shows you care about your community.

You can sign your name or not. It is up to you. If you want the buyer to know you made the piece then put your name on it, include a name tag, or business card.

From talking to people at the sale the last two years I've learned that most buyers want to know what **type** of wood was used, who made it, if it is food safe, and how to care for it.

Donated bowls that don't sell are carried over and added to the sale the following year.

**Chain Sharpening Service** from Jeff Zens: I have an electric chain sharpener and can accurately sharpen your chains and adjust depth stops for your saw chains. This service will restore the chain to "factory-new" condition. Most chains for 18" and shorter bars can be sharpened for \$10.00. Longer chains (up to 30" bars) are \$20.00 Badly damaged chains might be a little bit more. I will also tell you if the chain has reached the end of its useful life, and will not sharpen a chain beyond that point. This price is <u>only</u> available for club members.
