## President's Message April, 2020

### What's Next?

I'm willing to bet that you're all about as sick of this whole Wuhan corona virus business as I am. Nonetheless, it is seriously affecting our club's operation and I want to use this opportunity to update the membership on what we think is the future.

As I write this, the main hotspots in the United states for CoVid-19 are New York, New Jersey and Michigan, with several other smaller areas of concern spread around the country. It seems as though the reinfection rates are decreasing, and that's considered a good sign. Oregon has fared much better than these areas, but we are not yet out of the woods. The governor's mandate keeping non-essential businesses closed (this is one of the drivers of our present situation) remains in effect with no end in sight. One indicator of a potential timeline is Oregon's educational infrastructure: all colleges and K-12 school systems are closed for the remainder of the school year. I view this as a likely time period for other closures as well.

Compared to reopening businesses and schools, the decision to shut everything down was an easy one. Closing every possible door was justified as a life-saving measure; re-opening is fraught with peril for those responsible for that decision. Here is what I will propose to the board when the time comes to resume operations for our group.

First, we must wait for the governor to rescind the sequestration order. I have no way to even guess when that might happen, or what factors will influence her decision. It will probably be guided by health professionals whose advice seems to change from one day to the next. (Remember the weeks where masks wouldn't work to shield us from the virus? And now we should make them ourselves and wear them outside the house?) So that's first.

Second, we can't re-start our meetings until the Salem 50+ Center becomes available to us, and right now we do not know when that will be. I would not be at all surprised if the Center remains closed at least through May, largely due to the age of its most frequent visitors. This decision will be made by a different level of government and will be based on factors different than the governor's.

Once we pass these hurdles, I will recommend to the board that we start our meetings immediately. I'll make this recommendation based on my faith in the common sense I know each of our members is blessed with. I know each member will make his or her own independent assessment of any health or underlying medical conditions. I know you'll carefully consider the medical conditions and vulnerability of any family members with whom you're in regular contact.

I want our club back in operation as soon as possible – but we all want you all to be safe, and healthy, and turning wood, for as long as possible. So once we fire up the club lathe, we hope to see you – when you feel it's safe.

### **And Now This...**

If you are running out of suitable wood for our Empty Bowls community outreach, please contact Darcy Tataryn. He and I have been visiting Elwood's Tree Service from time to time, and taking advantage of his very generous ongoing donations. Darcy has been processing the logs into bowl blanks and has a number of blanks ready for your use. If we run short, we will get more and get it into a useable form for you.

You can thank Elwood by calling him the next time you need arborist work on your property.

Remember to be safe in your shop! Wear your protective gear, never turn without safety glasses, and...
